The municipality of Babina Greda owns land with an area of 43ha 37a 18 m2

(markings, geodetic ID No. 3584, 3587, 3562 and 3560, C.M. Babina Greda) in the Economic Zone "Krčevine" which has a total area of 47Ha 11a 82 m2 according to the Spatial Plan enters the zone of economic use and residential-mixed use.

Given that in the area of the Economic Zone "Krčevina" has a geothermal source, in the area of economic use it is allowed to carry out further investigations works and the exploitation of geothermal water, as well as the construction of buildings for the purpose is exploitation of geothermal water, which are:

In addition to the geothermal source, facilities for the production of electricity and/or heat energy as a resource can also use other renewable energy sources.

In the area of economic use, other than the construction of buildings for the purpose of utilising geothermal water as the primary purpose, it is possible to construct buildings for agricultural (except buildings for breeding livestock and poultry), business and hospitality tourist purposes, as well as infrastructure and storage buildings.

In addition to the mentioned basic purposes, sports and recreational buildings can be built as additional buildings on the construction site for gastronomic and tourist purposes.

In the residential-mixed-use area, it is possible to build residential buildings, business buildings, agricultural buildings, hospitality-tourist buildings and infrastructure buildings.

Your expression of interest would make it easier for the Municipality of Babina Greda to plan the terrain, arrange the environment and plan the complete communal infrastructure in the Economic Zone.

The Municipality can offer our potential investors the following:

- the possibility of adjusting the size of the particles according to the needs of the investor,
 which is not limited,
- professional assistance and cooperation in the development and realization of the investment,
- -help in connecting with local and regional institutions, business advisors and utility and infrastructure companies,
